System/University of Kentucky Community College System for Jefferson Community College for a mentor/internship program, for the Louisville Zoological Gardens' Boma (African Petting Zoo) and Australian Walkabout to interpret animal natural history, habitat preservation and African Culture for the public from July 1, 2019 through June 30, 2021.
