SECTION I: The following appropriation for the listed contract is hereby approved:

\$100,000.00 for a new not-to-exceed amount of \$200,000.00 for an amendment to the noncompetitively negotiated Professional Service Contract with Kentucky Community and Technical College

System/University of Kentucky Community College System for Jefferson Community College for a mentor/internship program, for the Louisville Zoological Gardens' Boma (African Petting Zoo) and Australian Walkabout to interpret animal natural history, habitat preservation and African Culture for the public from July 1, 2019 through June 30, 2021.
