**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept additional funding of \$99,059 for the continued design phase of the Dodge Gap section of the Louisville Loop at the Jefferson Memorial Forest.
