**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$400 each is hereby appropriated from Districts 11 and 7 Neighborhood Development Funds, by amending Ordinance No. 171, Series 2015, which approved \$18,250 in funding, for a new total of ~~\$18,650~~ \$19,050; through the Office of Management and Budget, to the

War Against Violence Corporation for costs associated with the "YouthAlert!" Violence Prevention/Health Community Outreach Program at Seneca High School and Kammerer Middle School.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
