**NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to combine three separate ~~Olmsted Parkways~~ Bicycle and Pedestrian Facilities grant awards into one award with a balance of \$1,869,532.34 in CMAQ funds. ~~Along with the original Eastern Parkway route,~~ The revised scope of work is to construct a multi-use trail along ~~Olmsted Parkways~~ in Louisville Southwestern Parkway and Algonquin Parkway in Louisville.
