**A RESOLUTION PURSUANT TO THE CAPITAL AND OPERATING BUDGET ORDINANCES, APPROVING THE APPROPRIATION TO FURTHER FUND THE FOLLOWING NONCOMPETITIVELY NEGOTIATED SOLE SOURCE CONTRACT FOR METRO SAFE FOR MAINTENANCE OF ITS NEWLY UPGRADED RADIO SYSTEM - MOTOROLA SOLUTIONS, INC. - (\$623,681.00).**

**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**WHEREAS,** In 2015, the Metro Council approved a sole source contract for Metro Safe with Motorola, Inc. for a radio system upgrade; and

**WHEREAS,** the amount of the contract as approved in 2015 was \$7,800,000.00; and

**WHEREAS,** upon successful implementation of the upgrade, which has occurred, Motorola was to provide system maintenance at an additional cost of \$623,681.00 per year; and

**WHEREAS,** a further appropriation is required to fund this maintenance provision of the contract.

**NOW, THEREFORE:**

**SECTION I:** The following appropriation for the listed contract is hereby approved:

**METRO SAFE**

\$623,681.00 for to fund the maintenance provision of the noncompetitively negotiated Sole Source Contract with Motorola Solutions, Inc. for professional services regarding a radio system upgrade from August 25, 2020 through August 24, 2021.
