FOR THE EASTERN HIGH SCHOOL TRACK 400M RENOVATION PROJECT (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$40,000~~\$42,750 is hereby appropriated from Neighborhood Development Funds in the following manner: \$25,000 from District 19; and \$5,000 each from Districts 17, 18, and 20; \$750 from District 16; \$500 each from Districts 2, 22, and 23; and \$250 each from Districts 11 and 14; through the Office of Management and Budget, to the Jefferson County Public Education Foundation, Inc.

for the Eastern High School Track 400M Renovation Project.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
