**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept an amendment to the current 4<sup>th</sup> Street Sidewalk Improvement Project to transfer design funding of \$88,925 to construction funding, an additional grant award of \$21,420 towards the construction phase, and extend the project's completion date to June 30, 2019.
