BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$8,250~~ \$10,500 \$11,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 13; \$1,750 from District 14; \$1,000 each from Districts 12, 15, and 23; and \$500 each from Districts 21 and 25; and \$250 each from

Districts 2, 8, and 17; to the Louisville Metro Parks Department for Forest Fest 2019, the annual Bluegrass Festival to be held at the Jefferson Memorial Forest.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
