#### ORDINANCE NO. , SERIES 2017

AN ORDINANCE APPROPRIATING \$13,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS BY APPORTIONING \$7,000 FROM DISTRICT 22 AND \$6,000 FROM DISTRICT 21, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO CHILDREN HAVE OPTIONS IN CHOOSING EXPERIENCES, INC. (C.H.O.I.C.E., INC.), FOR THE "DARE TO DREAM" SPORTS LEADERSHIP AND MENTORING PROGRAM.

### BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$13,000 is hereby appropriated from Neighborhood Development Funds by

apportioning \$7,000 from District 22 and \$6,000 from District 21, through the Office of Management

and Budget, to C.H.O.I.C.E., Inc., for the "Dare to Dream" sports leadership and mentoring program.

SECTION II: The Council has determined that the funds requested in this Ordinance will be

expended for a public purpose.
