**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$6,650~~ \$6,900 \$8,800 is hereby appropriated from Neighborhood Development Funds in the following manner: \$500 each from Districts 16, 17, 20, 21, 25, 13, 9, 14, 24, 22, 11, 12; \$250 each from Districts 16, 15, 21, 2, 1, 8, 25, 17, 20, 23, 4, 5; \$200 each from Districts 3, 7, 6, \$400 from District 7; \$750 from District 14; through the Office of Management and Budget, to Good Health Ideas, Inc., dba Colon Cancer Prevention Project, for designing, printing and distribution of educational materials.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
