## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$8,500 \$11,500 \$13,000 is hereby appropriated from Neighborhood

Development Funds in the following manner: \$5,000 from District 12: \$1,000 each from Districts 10,

File #: O-658-21, Version: 3 13, 14, 15, 21, 24, and 25; and \$500 each from Districts 17 and 22; through the Office of Management and Budget, to Harbor House of Louisville, Inc. to assist with the construction of the Intergenerational Life Center. SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose. SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance. **SECTION IV:** This Ordinance shall take effect upon its passage and approval.
