AN ORDINANCE APPROPRIATING \$5,750 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 EACH FROM DISTRICTS 12 AND 5; \$750 FROM DISTRICT 1; AND \$500 EACH FROM DISTRICTS 4, 13, 14 AND 25; TO METRO PARKS FOR THE URBAN WILDERNESS CANOE ADVENTURE TO BE HELD OCTOBER 1ST AT RIVERVIEW PARK AND SEPTEMBER 30TH AT SHAWNEE PARK.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$5,750 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 each from Districts 12, 5; \$750 from District 1; and \$500 each from Districts 4, 13, 14, 25; to Metro Parks for the Urban Wilderness Canoe Adventure to be held October 1st at Riverview Park and September 30th at Shawnee Park.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
