**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,250~~ \$6,750 \$7,250 is hereby appropriated from Neighborhood Development Funds in the following manner: \$500 each from districts 13, 14, 6, 24, 15, 22, 20, 4, 3, 10, 12, 21, 8; \$250 each from districts 5, 25, 2; through the Office of Management and Budget, to Good Health Ideas, Inc., dba Colon Cancer Prevention Project,

for staffing, designing and printing educational materials and advertising.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
