SECTION I: The Mayor is hereby authorized to enter into a supplemental agreement with Commonwealth of Kentucky Transportation Cabinet to accept an additional \$967,000 to fund the right of way phase of the Buechel Bank Road Widening Project to be administered by the Department of Public Works and Assets.

SECTION II: This Resolution shall become effective upon its passage and approval.
