BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,000 is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$2,500~~ \$2,300 ~~\$2,200~~ from District 18; \$500 from District 16; \$300 from District 14; \$250 each from Districts 9, 10, 12, 13, 15, 17, 20, and 22; \$200 each from Districts 1, 2, ~~and 7, and 21~~; and \$100 each from Districts 3 and 4; through the Office of Management and Budget, to The Start the Heart Foundation, Inc. for the purchase of CPR dummies, pumps, and an AED trainer.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
