## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$6,125 from District 9 Neighborhood Development Funds to the

Division of Community Forestry to pay for weekly tree watering on Frankfort Avenue.

SECTION II: The Council has determined the funds requested in this Ordinance will be

expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
