**A RESOLUTION APPROVING THE APPROPRIATION TO FUND AN ANNUAL CONTRACT WITH HR ALLIANCE IN THE AMOUNT OF \$15,000.00.**  
**SPONSORED BY: COUNCIL PRESIDENT YATES AND COUNCIL MEMBERS LEET AND GREEN**

**WHEREAS**, Ordinance No. 127, Series 2017, and Resolution No. 062, Series 2017, modified Metro’s ethics tip line to establish a process for employees of Metro Council to file a complaint of harassment;

**WHEREAS**, the Louisville Metro Council’s amendments to the ethics tip line requires the Louisville Metro Auditor to administer a contract with a Third Party Investigator who will investigate all complaints from or regarding any Metro Council members or employees of Metro Council; and

**WHEREAS**, in response to the Request for Proposal issued by Louisville Metro Auditor, May Porter, for the Third Party Investigator, the HR Alliance submitted a proposal (attached hereto) with

the service and methodology it would use if selected as the Third Party Investigator for complaints of harassment.

**NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/ JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:**

**SECTION I:** The proposed annual contract with HR Alliance for Workplace Investigation Services is hereby approved by the Legislative Council of the Louisville/ Jefferson County Metro Government as required in Louisville Metro Code of Ordinances § 39.140(F).

**SECTION II:** The \$15,000.00 appropriation is hereby approved for a Service Contract with HR Alliance for Workplace Investigation Services for one year from the date of execution.

**SECTION III:** This Resolution shall take effect upon its passage and approval.
