BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$27,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 each from Districts 6, 1, 2, 4, 5, 10, 12, 14, 17, 23, and 26; \$1,500 from District 20; \$1,000 from District 9; and \$500 each from Districts 8, 13, 15, 21, and 25; through the Office of Management and Budget, to Kentucky Shakespeare, Inc. for costs associated with the 2019 MacBeth Tour.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
