THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO APPALSHOP, **INCORPORATED** FOR REIMBURSEMENT OF **PROGRAMMING AND** ENTERTAINMENT COSTS KENTUCKY **RURAL-URBAN** FOR ITS **EXCHANGE** LOUISVILLE COMMUNITY INTENSIVE WEEKEND.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:
