Section I: That the zoning of the property located at 9120 Blowing Tree Road, containing 19.468 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 14ZONE1060, is hereby changed from R-4 Single Family Residential to R-6 Residential Multi-Family; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 14ZONE1060.
