**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:**

**SECTION I:** The total of ~~\$46,750~~ \$17,000 \$18,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 13; \$3,500 from District 14; \$1,500 from District 15; \$1,000 each from Districts 12, 23, 24, 25; \$750 from District 1; \$500 each from Districts 10, 17; and \$250 each from Districts 3, 4, 5, 6, 7, 8, 9, 21, 22; to the Louisville Metro Parks Department for ForestFest 2017, the annual Bluegrass Festival to be held at the Jefferson Memorial Forest.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
