BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO **GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

SECTION I: The sum of \$10,000\$30,000 is hereby appropriated from Neighborhood Development Funds in the following

manner: \$5,000 each from Districts 3, 4, and 17, and 21, \$3,000 from District 13, \$1,000 each from Districts 14, 20, 22,
