BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$8,912.50 is hereby appropriated from District 21 Neighborhood Development Funds, through the Office of Management and Budget, to Brightside for funding the Brightside Education Program which includes public outreach to reduce litter in district hotspots.
