**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,001~~ \$5,301 \$7,824 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$3,049 from District 17; \$652 from District 18; \$500 each from Districts 8, 16, 7, 14; \$300 each from Districts 14, 7; 20, 24, 13, 15, 25, 26; \$250 from District 5; \$73 from District 23; through the Office of Management and Budget, to the Louisville-Thruston Chapter of the Kentucky Society of the Sons of the American Revolution for color guard uniforms.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
