A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT \$2,180,000 OF FUNDING FROM THE COMMONWEALTH OF KENTUCKY TRANSPORTATION CABINET FOR THE CONSTRUCTION PHASE OF THE WEST END PAVING PROJECT TO BE ADMINISTERED BY THE DEPARTMENT OF PUBLIC WORKS & ASSETS.

WHEREAS, the Louisville/Jefferson County Metro Government wishes to enter into this agreement through the Department of Public Works & Assets.

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept \$2,180,000 of funding for the construction phase for the West End Paving Project. Rehabilitation will include portions of Muhammad Ali Boulevard, River Park Drive, Chestnut Street, Market Street and 16th Street.

SECTION II: This Resolution shall take effect upon its passage and approval.
