BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$8,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 15; \$1,000 each from Districts 12, 13, 14, 21 and 25; and \$500 from District 10; to Metro Parks, for Iroquois Amphitheater's free movie series and general programming support.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
