TO HELP FUND THE ANNUAL BUY LOCAL FAIR (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (“THE COUNCIL”) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$4,900~~ \$7,375 \$9,525 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 9; \$850 from District 10; \$725 from District 4; \$600 from District 8; \$500 each from Districts 2, 13, and 24; \$350 each from Districts 1, 12, 14, 15, 17, 21, and 25; and \$300 each from Districts 6, 7 and 20; and \$250 each from Districts 3 and 16; through the Office of Management and Budget, to the Louisville Independent Business Alliance, Inc. to help fund the annual Buy Local Fair.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
