**WHEREAS,** Louisville Metro Government wishes to make an application for United States Department of Homeland Security and/or Commonwealth of Kentucky funds for a project to be administered by the Kentucky Office of Homeland Security through the Louisville Metro Police Department; and

**WHEREAS**, it is recognized that an application for and approval of the Kentucky Office of Homeland Security funds imposes certain obligations and responsibilities upon the city.

**NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to execute and furnish all required documents, including a memorandum of agreement, as may be required by the Kentucky Office of Homeland Security (KOHS) for the furtherance of the above referenced project and to act as the authorized correspondent for said project.

**SECTION II:** The Mayor is hereby authorized to accept up to \$656,469 from the KOHS to retrofit LMPD's firearms training center.

**SECTION III:** This Resolution shall become effective upon its passage and approval.
