**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$8,000~~ \$11,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$8,000 from District 5; \$250 each from Districts 2, 3, 9, 12, 13, 16, 22, 23; \$300 from Districts 10, 21; \$400 from District 7; through the Office of Management and Budget, to One Plus One Equals U, Inc. for the Summer Youth Enrichment Program (SYEP).

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
