**WHEREAS**, a Collective Bargaining Agreement has been reached between Louisville/Jefferson County Metro Government and Teamsters Local 783 affiliated with the International Brotherhood of Teamsters of America representing Louisville Emergency Medical Services and Office of Management and Budget - EMS Billing Services, concerning wages, hours, and terms and conditions of employment; and
