Now therefore be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government as follows:

**Section I:** That the zoning of the property located at 10509 Bardstown Bluff Road containing 33.972 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 15ZONE1015, is hereby changed from RR Rural Residential to R-5A Residential Multi-Family; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 15ZONE1015.
