**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,000~~ \$11,000 ~~\$12,000~~ is hereby appropriated from Neighborhood Development Funds

in the following manner: \$4,500 from District 21; \$3,000 from District 15; \$1,000 from Districts 13 and 25; \$500 from Districts 3, 10, 12, and 14; and \$250 from Districts 1 and 17, through the Office of Management and Budget, to South Louisville Community Ministries, Inc. ("SLCM") for expenses associated with families helping families and supporting SLCM's emergency rental assistance.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
