**WHEREAS,** the Department of Public Works and Assets may accept \$20,000 from Metropolitan Sewer District; and

**WHEREAS,** the Metro Government wishes to enter into this Memorandum of Agreement with Metropolitan Sewer District through the Department of Public Works and Assets.

**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to enter into a Memorandum of Agreement and receive a stipend of \$20,000 from Metropolitan Sewer District for improvements generally consisting of installing curb, gutter, drainage pipe and catch basin along with other general roadway improvements on Drescher Bridge Avenue.

**SECTION II:** This Resolution shall take effect upon its passage and approval.
