BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$6,250~~ \$6,750 \$12,800 is hereby appropriated from the Neighborhood Development Funds in the following manner: \$4,000 from District 22; \$1,000 each from Districts 7, 14, and 21; \$500 each from Districts 1, 4, 5,

6, 10, and 13, and 16, 17, 24, and 25; \$300 from District 3; and \$250 each from Districts 9 and 20; through the Office of Management and Budget, to Junior Achievement of Kentuckiana, Inc. for curriculum materials.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
