AN ORDINANCE APPROPRIATING \$36,250 FROM DISTRICT 23 NEIGHBORHOOD DEVELOPMENT FUNDS; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO ARBOR CREEK, SECTION 2 CONDOMINIUMS COUNCIL OF CO-OWNERS, INC. FOR PAVING ARBOR MANOR WAY, ARBOR BROOK LANE AND ARBOR FALLS DRIVE (AS AMENDED).

SPONSORED BY: COUNCIL MEMBER PEDEN

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$36,250 is hereby appropriated from District 23 Neighborhood Development Funds; through the Office of Management and Budget, to Arbor Creek Section 2 Condominiums Council of Co-owners, Inc for paving Arbor Manor Way, Arbor Brook Lane, and Arbor Falls Drive. These streets are not to be closed to the public, and the funds appropriated to this project from Metro Louisville shall not be spent until private funds are first spent.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of
