THREE **POINTS BEAUTIFICATION** COUNCIL. FOR THE **PROJECT** GOSS AVENUE AND LOGAN STREET.

## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$6,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$4,000 from District 10; \$2,500 from District 4; through the Office of Management and Budget, to the Schnitzelburg Area Community Council, Inc. for the Three Points Beautification Project at Goss Avenue and Logan Street.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.
