AN ORDINANCE APPROPRIATING \$30,000 FROM DISTRICT 3 NEIGHBORHOOD DEVELOPMENT FUNDS, THROUGH DEVELOP LOUISVILLE/LOUISVILLE FORWARD. TO THE **OFFICE** OF HOUSING TO **ASSIST** LOW INCOME **HOMEOWNERS** WITH **EMERGENCY** REPAIRS AND ANTI-FORECLOSURE ASSISTANCE, AND RENTERS WITH ANTI-EVICTION ASSISTANCE. SPONSORED BY: COUNCIL MEMBER DORSEY

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$30,000 is hereby appropriated from District 3 Neighborhood Development Funds, through Develop Louisville/Louisville Forward, to the Office of Housing to assist at the 100% AMI level or below, owner-occupant homeowners with emergency repairs and antiforeclosure assistance and renters with anti-eviction assistance, once all other funding sources are exhausted. Funds may also be used to assist any residents with any emergency or temporary shelter needs,
