FOR PROGRAM EXPENSES ASSOCIATED WITH CONDUCTING THE "SPIRIT OF THE DRUM." (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$17,500~~15,000~~16,500~~ is hereby appropriated from Neighborhood Development Funds in the

following manner: \$5,000 each from Districts 1 and 5; \$2,500 from District 5; \$1,000 each from Districts 2, 3, 4, and 6; \$500 each from Districts 7, 9, 10, 13, 14, 15, and 21; and \$250 each from Districts 12, 16, 17, 22, 24, and 25; through the Office of Management and Budget, to River City Drum Corp Cultural Arts Institute, Inc. for program expenses associated with conducting the "Spirit of the Drum."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
