BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$5,001~~ \$13,500 is hereby appropriated from the District 21 Neighborhood Development Funds in the following manner: \$11,500 from District, 21; \$1,000 from District 7; \$500 from District 3; \$250 each from Districts 2 and 17; through the Office of Management and Budget, to House of Ruth, Inc. for the purchase of a cargo van.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
