SECTION I: The Mayor is hereby authorized to execute and furnish all required documents, including a memorandum of agreement, as may be required by KOHS for the furtherance of the above referenced project and to act as the authorized correspondent for said project for which Metro shall be reimbursed subject to the Project grant terms and conditions.

SECTION II: The Mayor is hereby authorized to make application for and, upon approval, enter into an agreement with the Kentucky Office of Homeland Security.

SECTION III: This Resolution shall become effective upon its passage and approval.
