# BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$46,000 is hereby appropriated from Neighborhood Development Funds in the following

manner: \$28,000 from District 23; \$12,000 from District 24; and \$6,000 from District 13; to Metro Parks for the 2018

FridayFest Concert Series at Highview Park.
