**Be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government (The Council) As Follows:**

**SECTION I:** Part I. I. Public Works & Assets of Ordinance No. 101, Series 2014 is hereby amended as follows:

**SECTION II:** Louisville Metro Government and Commonwealth of Kentucky Transportation Cabinet both wish to enter into an agreement to move forward with the supplemental agreement for I-65 Ramp to Brook Street as listed in Section I of this Ordinance.
