WHEREAS, Louisville Metro Government wishes to make an application for United States Department of Homeland Security and/or Commonwealth of Kentucky funds for a project to be administered by Kentucky Office of Homeland Security through the Louisville Metro Police Department,

WHEREAS, it is recognized that an application for and approval of Kentucky Office of Homeland Security funds impose certain obligations and responsibilities upon the city,

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to execute and furnish all required documents, including a memorandum of agreement, as may be required by KOHS for the furtherance of the above referenced project and to act as the authorized correspondent for said project.

SECTION II: The Mayor is hereby authorized to accept up to \$18,000 from the Kentucky Office of Homeland Security upon approval. Funds will be utilized to fund the purchase of body armor.

SECTION III: This Resolution shall become effective upon its passage and approval.
