File #: O-399-16, Version: 3 **GOVERNMENT (THE COUNCIL) AS FOLLOWS: SECTION I:** The sum of \$10,950 \$12,450 \$19,200 is hereby appropriated from the Neighborhood Development Funds in the following manner: \$3,000 from District 3; \$2,500 from District 20; \$2,000 each from Districts 3, 1, 20, 21; \$1,000 each from Districts 2 and 25; \$750 from District 5; \$700 from District 6; \$500 each from Districts 5, 8, 9, 10, 11, 12, 16, 17, and 22, 23, 24, and 26 and \$250 each from Districts 7, 10, 13 and 15; through the Office of Management and Budget, to United Nations Association of the United States of America Kentucky Division, Ltd. For programming expenses associated with conducting the Human Trafficking Conference: Local to Global. **SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose. SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance. **SECTION IV:** This Ordinance shall take effect upon its passage and approval.
