SECTION I: The sum of \$15,000 is hereby appropriated from the District 14 Neighborhood Development Fund, through the Office of Management and Budget, to the Jefferson County Public Education Foundation, Inc. to purchase playground equipment for Eisenhower Elementary School and the surrounding community.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
