**Schedule A**

**Fiscal Year 2023 Budget**

That there is authorized the following expenditures for the operation of the Jefferson County Sheriff's Office during the calendar year 2023. The total sum of \$34,126,185 shall be allocated as follows:

<b>Personnel</b>	<b>\$29,485,385</b>
<b>Operating</b>	<b>\$ 3,260,800</b>
<b>Capital</b>	<b><u>\$ 1,380,000</u></b>
<b>TOTAL</b>	<b>\$34,126,185</b>

There is further authorized a personnel complement of 329 employees. The total estimated funds available for appropriation during calendar year 2023 are \$34,129,050 in revenues. The anticipated four-year term ending cumulative surplus is projected to total \$4,450,600 at the close of calendar year 2022.
