BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$5,500 \$6,250 from Neighborhood Development Funds in the following manner: \$3,000 from District 15; \$1,000 from District 25; and \$500 each from Districts 12, 13, and 14, and 21; and \$250 from District 5; to Metro Parks for the Jack-O'-Lantern Spectacular event in Iroquois Park.
