BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$43,200~~ \$59,200 \$60,200 is appropriated from Neighborhood Development Funds in the following manner: \$6,400 each from Districts 23, ~~57~~; ~~\$8,000~~\$11,200 from District 12; \$9,600 from District

7; \$4,800 each from Districts 3, 10, 11; \$3,200 each from Districts 17, 21; \$1,600 each from Districts 4, 8, 9; \$1,000 from District 6; through the Office of Management and Budget, to Commonwealth Theatre Center, Inc., for programming expenses associated with performances of "The Boy Who Cried Wolf."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
