**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON**

**COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The amount of ~~\$9,500~~ \$14,000 ~~\$18,500~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 4; \$1,500 each from Districts 3, 7, and 25; \$1,000 each from Districts 1, 2, 6, 7, 9, 10, 15, 20, and 24 25; and \$500 each from Districts 5, 13, 14, 19, 21, and 23, and 26; and \$250 each from Districts 17 and 22; through the Office of Management and Budget, to the Waterfront Development Corporation for The Second Annual Juneteenth Jubilee in Waterfront Park.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
